Marlborough Mansions is located within easy walking distance of West End Lane as well as being a short distance from either West Hampstead or Finchley Road underground stations







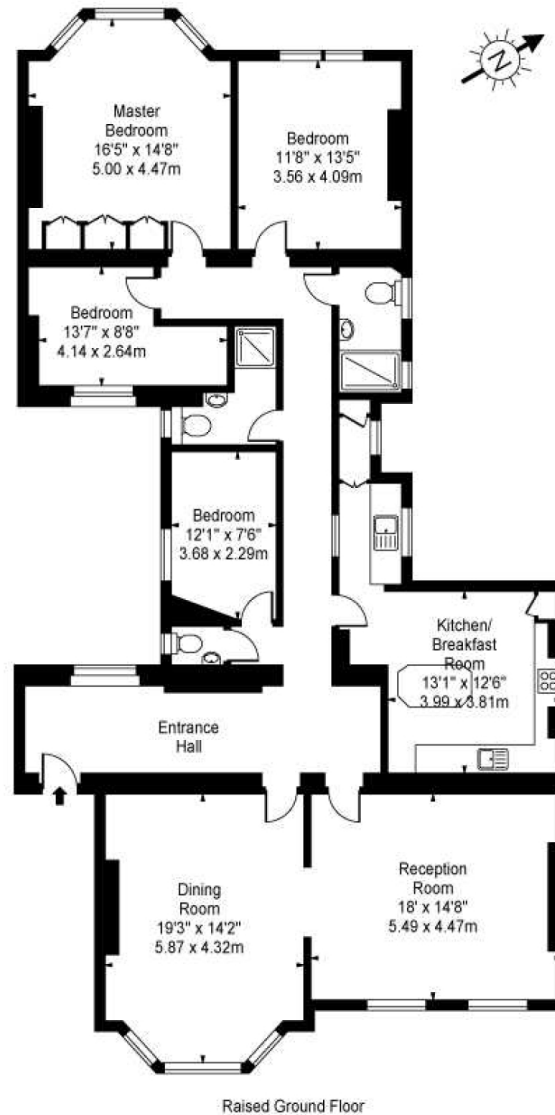

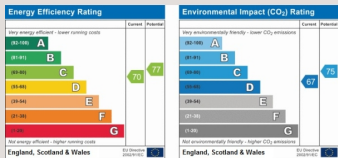
