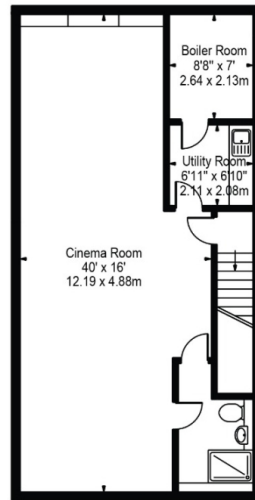

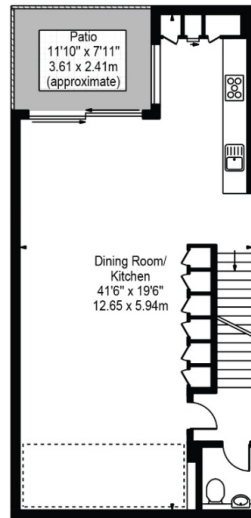
Second Floor



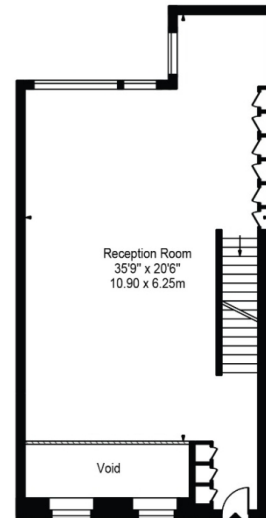
First Floor

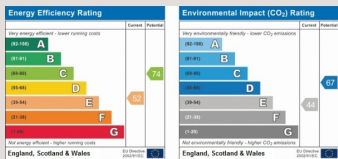
